APPROVAL OF MINUTES: Motion by Bergman, second Moen, to approve the minutes from the December 17, 2018, meeting. Motion carried.

Department Reports:

Budget: Included with members' packet. Harris reviewed the budget for the time period ending January 31, 2019.

Forest Management Operations: Golembiewski reported very busy hauling; March timber auction prospectus mailed out (26 sales); American Birds Conservancy project work continues; Forester leaving for a different position; and interviews to be held soon for two seasonal summer forestry positions.

Parks and Recreation: Schroeder reported working continues with FEMA; Park Creek Pond dam project out for bids until end of March; snowmobile and ski trails are in good condition; recruitment for seasonal summer park staff moving slowly.

ACTION ITEMS/REFERRALS:

WDNR Sustainable Forestry Grant Application FY2019: This is a two year grant, totaling approximately \$8,500, for five experimental regeneration trials: deer exclusion fencing for cedar growth regeneration, and white pine and spruce seeding in a variety of areas on the County Forest.

ACTION: Motion by Bergman, second Long, to approve WDNR Sustainable Forestry Grant Application FY2019. Motion carried.

2018 Budget:

Carryovers/Reserves: Harris reviewed.

ACTION (**REFFERAL/RESOLUTION**): Motion by Moen, second Bergman, to approve carryovers/reserves as presented, and refer to Administration Committee and County Board. Motion carried unanimously.

Year-end Transfer of Excess Revenue to the General Fund: Reviewed.

ACTION (**REFERRAL/RESOLUTION**): Motion by Long, second Moen, to approve transfer of \$1,167,000 to the General Fund, and refer to Administration Committee and County Board. Motion carried unanimously.

Release of Reserve Funding: Release of reserve funding requested.

ACTION (**REFERRAL/RESOLUTION**): Motion by Bergman, second Moen, to approve release of reserve funding as presented, and refer to Administration Committee, and County Board. Motion carried unanimously.

Release of Capital Reserve Funding: Release of reserve funding requested.

ACTION (**REFERRAL/RESOLUTION**): Motion by Liebaert, second Bergman, to approve release of capital reserve funding as presented, and refer to Administration Committee, and County Board. Motion carried unanimously.

Town of Summit Property Acquisition:

Property Acquisition: Property owner interested in selling 40 acre parcel in the Town of Summit to Douglas County. Parcel is surrounded by Douglas County Forest Lands and is about 80% wooded. Requesting \$25,000 to purchase the parcel with up to an additional \$2,000 for closing costs and other related acquisition expenses for a total not to exceed \$27,000.

ACTION (**RESOLUTION**): Motion by Long, second Moen, to approve acquisition of property located in Town of Summit at an amount up to \$27,000, and forward to County Board. Motion carried unanimously.

Release of Capital Reserve Funding (Land Acquisition): Release of reserve funding requested.

ACTION (**REFERRAL/RESOLUTION**): Motion by Bergman, second Moen, to approve release of capital reserve funding (land acquisition) in an amount up to \$27,000, and refer to Administration Committee and County Board. Motion carried unanimously.

Upper St. Croix Forest Land Conservation Project (The Conservation Fund): Joint Committee on Finance has approved the project; should be completed in 2019, and adds approximately 1800 acres to county forest.

Extended Timber Sale Contracts: Contract list reviewed (correspondence to contractors in packet).

2018 Wisconsin County Forest Certification Audit Report: Taylor, Lincoln, Oneida and Langlade counties selected for 2018 audit (report included in meeting packet). Douglas County has been selected for the 2019 audit, to occur the week of August 5th.

2018 Public Land Timber Sale Report: Reviewed; Douglas County ranked second highest in state at \$4,480,663.27 in total sales value and highest in total volume harvested at 105,903 cord equivalents.

2018 Timber Sale Revenue Record: Reviewed.

2018 Town Severance Payment Record: Reviewed; severance and acreage share payments totaled \$598,664.20.

2019 Spring Logger's Discussion Forum: Tuesday, April 9, 2019.

March 5, 2019, Timber Sale Reminder: Liebaert will not attend.

WDNR County Forest Liaison: Latvala reported things are going very well with WDNR County Forest project work; ABC habitat project and grant reforestation projects are good opportunities for county to partner with the state.
