## **Land Conservation:**

**Support Creation of Agriculture Enterprise Area in Douglas County:** To qualify for Farmland Preservation Agreement with a tax incentive, the property must be located in a farmland preservation zone (Douglas County does not have) or an agriculture enterprise area. Farmers must petition an area to be designated as agriculture enterprise to the state, with town and county support.

**ACTION (RESOLUTION):** Motion by Baker, second Borgeson, to support resolution as presented and refer to County Board. Motion carried unanimously.

## **Budgetary Transfers:**

Record Funding of \$1,300 for the Superior Bay and Pickle Pond Yellow Iris Response: Transaction to accept grant funds.

Record Funding of \$1,801.95 for the AIS Butterfly Dock EDRR Project: Transaction to accept grant funds.

**ACTION (REFERRAL):** Motion by Baker, second Ryan, to approve budgetary transfers and refer to Administration Committee. Motion carried.

**Great Lakes Committee Grant for AIS Cleaning Stations Approval:** Vande Voort to apply for grant for AIS cleaning stations.

Resolution Regarding Wisconsin Department of Natural Resources Surface Water Grants for Aquatic Invasive Species: Authorization needed to apply for grants through WIDNR.

**ACTION (RESOLUTION):** Motion by Baker, second Borgeson, to support resolution as presented and refer to County Board. Motion carried unanimously.

#### **INFORMATIONAL ITEMS:**

**POWTS Postcards:** Final round of postcards mailed this year to inform property owners of septic inspection requirement every three years. Inspections may be done by pumpers, plumbers and other trained inspectors. Many companies are not following through with reporting requirements of septic pumping within thirty days; records cannot be updated without information. If a system is found to be failing, a property owner has twelve months to replace or repair, unless an imminent health threat is determined.

**Douglas County Zoning Ordinance 8.0 Update:** Ordinance updates to be done in areas of campgrounds, signs, and A-2 zone district. Campground requirements are currently ambiguous; more guidelines will make permitting process more efficient. Sign guidelines are out-of-date with current regulations; A-2 zone district created for captive cervids and Concentrated Feeding Animal Operations.

**Fire Numbers:** Fire numbers not currently issued to vacant parcels, as interpreted from the public safety Ordinance. A survey of other Wisconsin counties suggest most issue fire numbers to vacant parcels, as requested. Emergency operations anticipate a benefit in issuing more numbers to locate those in distress. Zoning Department will consider assigning vacant parcels fire numbers and charging higher fee, due to labor and travel requirements.
