APPROVAL OF MINUTES: Motion by Pomush, second Ryan, to approve October 7, 2021, minutes. Motion carried.

DEPARTMENTAL FINANCIAL REPORTS AND GOALS/OBJECTIVES FOR 2021: Administration/Human Resources: Recruiting for multiple positions; performance evaluations began; health insurance open enrollment. **Buildings and Grounds:** Fully staffed; working on multiple building projects, including elevator failure. **Corporation Counsel:** Opioid litigation will require resolution to sign participation agreement in settlement. **County Clerk:** Public hearing to be held November 10, 2021, to adopt final County Board Supervisory District Plan; one vacant position. **Finance/Information Services:** Attending two-day training on multiple finance aspects; upgrading JD Edwards software. **Register of Deeds:** One vacant position. **Treasurer:** Tax collection up 21%; 131 properties in tax deed status for 2022.

ACTION ITEMS/REFERRALS:

From the Public Safety Committee – Revision of Holiday Pay Schedule for Communication Center Workers: Policy revision distributed. Holiday pay was rolled into wages when union existed. Revision request is to exclude Communication Center dispatchers from Section III – Time Away From Work, sub. (C)(2). Workers will then receive holiday pay of eight hours per holiday for 10 ½ holidays per year, in addition to being paid for actual hours worked at time and a half, at an approximate fiscal impact of \$25,000 annually. Amendment also includes addition of sub. (C)(3): "Temporary employees who work in the Jail and Communication Center on a designated holiday will receive overtime pay of one and one half times the hours worked."

ACTION (RESOLUTION): Motion by Baker, second Pomush, to approve Personnel Policies amendment in Section III – Time Away from Work, as presented, and refer to County Board. Motion carried unanimously.

Budgetary Transfers: Included with agenda.

ACTION (RESOLUTION): Motion by Ryan, second Baker, to approve and refer to County Board. Motion carried unanimously.

INFORMATIONAL ITEM:

Levy Limit Increase/Sales Tax: All chairs at Wisconsin Counties Association voted to pass .5% sales tax increase; awaiting next steps. No change to levy limits.
